

5 Singapore Airlines

- The group, which includes Singapore Airlines and Scoot, carried a combined 3.3 million passengers during the month, an increase of 7.0% from a year earlier [18 Nov 2024, MT Newswires]
- Singapore Airlines said the merger of Vistara with Air India has been completed, with Singapore Airlines now holding a 25.1% stake in the enlarged Air India (13 Nov 2024, MT Newswires)





- Tesla excluded from EV Buyer Credits in California Proposal (26 Nov 2024, Bloomberg)




Coinbase

4 MicroStrategy

- MicroStrategy looks set to join the Nasdaq 100 index, prompting a major reconstitution of the index (30 Nov 2024, Benzinga)
- MicroStrategy bought a record US\$5.4 billion in Bitcoin, the third major purchase announced this month by the crypto hedge fund proxy. Using the proceeds from a US\$3 billion convertible note issue and common share sales, the Tysons Corner, Virginia-based firm acquired 55,500 tokens from 18 Nov 2024 through 24 Nov 2024 [25 Nov 2024, Bloomberg]
- Taiwan Semiconductor Manufacturing Co is making waves in the semiconductor industry with a US\$65 billion investment in Arizona, bolstering the US's advanced chipmaking capabilities. The US will likely secure the second-largest global market share in advanced semiconductor production by 2027, increasing its share from 9% to 21% [26 Nov 2024, Benzinga]




